Christian County will be holding an election for a person to represent LAA 2 beginning January 1, 2007. That position is currently held by R Douglas Mosley. LAA 2 includes the communities of Consolation, Sinking Fork, Cerulean, Castleberry, Pod, Bainbridge, and Macedonia.

Any person who does not receive a ballot and lives in LAA-3 may request a ballot from FSA. Ballots will be mailed in early November and must be returned by 12/04/06.

Committee Nominees: Nominees who are on the ballot are Jerry Sanderson and James McReynolds. There is also space for voters to write in names of persons for whom they wish to cast their ballot. Elections are held each year to elect or re-elect a member(s) whose term will expire.
