COUNTY COMMITTEE ELECTION

The producers in LAA - 2 are holding an election to elect a committee member for a three year term. LAA-2 covers Mt. Carmel, Beechburg, Flemingsburg and Foxport area of the county. Sam White currently holds that position. Names on the ballot are Helen Caudill, Robert A List and Sam White. The person getting the most votes will be elected for a three year term beginning in January 2007. The other two will serve as First and Second Alternate to the County Committee. Ballots are scheduled to be mailed to voters on November 3, 2006. If you are an eligible voter and do not receive a ballot, you may request one from the office. Ballots will be counted in the Fleming County FSA Office on Wednesday, December 6th at 9:00 a.m. The counting of votes is open to the public.

ROWAN COUNTY OFFICE UPDATE

The Rowan County Farm Service Agency located in Morehead will now be serviced by the Fleming County FSA office located in Flemingsburg. The office in Morehead will be open every Tuesday from 8:30 am thru 4:00 pm. Office staff from Flemingsburg will be providing service to the producers of Rowan County. Service may be limited in Flemingsburg on Tuesdays.

DCP PAYMENTS

Final Direct and Countercyclical (DCP) payments have been made for the 2005 and 2006 crop year. These payments are made by direct deposit. Statements are being mailed to producers as this is being written.

FARM LOAN PROGRAM

Farm Loan Program is administered in Fleming County by the Farm Loan Team. This Team consists of Charles J. Whitehead, Farm Loan Manager. Chuck has been with FSA for 11 years. Farm Loan Officers are Carolyn Sauer and Terrence Hill. Carolyn has been with the agency for 28 years and Terrence for 6 years. Program Technicians are Lisa Slone and Gera Hampton. Lisa has been with FSA for 6 years and Gera for 7 years. Farm Loan Program administers loans for the following uses. Annual operating loans, equipment purchases, cattle, real estate and youth loans. Youth loans are for FFA or 4-H projects for applicants between the ages of 10 and 20. The Farm Loan Team looks forward to assisting you with your loan needs.
