BANK ACCOUNT CHANGES

All FSA Payments, (LCP, CDP, TTPP, CRP, NAP) are to be issued electronically into your bank account, unless there is a Electronic Funds Transfer (EFT) Hardship Waiver Request on file with the County Office. In order to make timely payments, you need to notify the County office if you close your account or if another financial institution purchases your bank. Payments can be delayed if we are not aware of changes to your account and routing numbers.
