### Thank You David Bingham!

David Bingham is currently serving as the Chairperson of the Pulaski County FSA Committee. ### LAA-1 Committee Boundaries

Eligible voters in LAA-1 will be selecting someone this fall to represent them on the County Committee. Ballots will be mailed on November 3, 2006 to farm owners and producers in the northeastern part of Pulaski County. The communities of Shopville and Mount Victory are included in LAA-1. The boundary is East of a line that begins at Lincoln County and follows Highway 39 to Highway 452 to Highway 3266 to Highway 39 to Highway 1247 to Highway 80 to

Highway 769 to Buck Creek to the Cumberland River and ends at McCreary County. The ballots must be returned to the County Office by December 4, 2006.

### Meet the Candidates

Three persons have filed nomination forms for the Pulaski County FSA Committee Election. One of these persons will be selected by voters to represent the farmers in LAA-1. A brief biographical sketch is provided to inform voters about the candidates. The sketches are provided in alphabetical order.

#### Robby Cable

Mr. Cable has been a resident of Pulaski County for 39 years and has been a farmer for 26 years. He and his wife Brenda operate a beef cattle, tobacco, and hay farm. They have three daughters and one granddaughter. He is a member of the Hazeldell Church of Christ.
