Beet processors, cane processors, and cane refiners in the United States are required by the Federal Agriculture Improvement and Reform Act of 1996, as amended, to report data on physical quantities of stocks, production, imports, sales, and inventory adjustments to the Farm Service Agency (FSA) on a monthly basis. These data are compiled to produce the monthly Sweetener Market Data (SMD) report. Commercial sugar users, distributors, and traders are not required to report their stocks, imports, or exports data.

SEPTEMBER 2008 SUGAR MARKET REVIEW

Monthly Summary:

Beginning stocks in September are higher than a year ago by 130,007 STRV. Total production is down by 168,049 STRV, with beet sugar production down 125,101 STRV and cane sugar production down 42,948 STRV from a year ago. Total imports are up by 24,223 STRV. Total supply is down by 13,818 STRV from last September.

Total deliveries in September are up by 134,496 STRV than a year ago. Deliveries for domestic human consumption are up 129,240 STRV. Total sales for export have decreased 13,199 STRV from a year ago. Total use is up 120,859 STRV from September 2007. Ending stocks are down 134,677 STRV from a year ago.

Fiscal Year (FY) to Date Summary:

Total FY 2008 production to date is down 295,883 STRV with beet sugar production down 286,859 STRV and raw cane sugar production down slightly by 9,025 STRV. Total imports are up by 524,920 STRV, imports for direct human consumption are up significantly by 426,815 for the same period last FY. Total supply is up 330,011 STRV from FY 2007.

Cumulative sales for export are down significantly by 218,400 STRV, compared to the same period last FY. Total FY deliveries to date are up 638,398 STRV. Deliveries for domestic human consumption are up 657,353 STRV from last FY. Total FY use is up 464,689 STRV from the same period in FY 2007.
