2011 ELAP and LIP Sign Up

Sign up deadlines are approaching for FSA's Emergency Assistance for Livestock, Honey Bees, and Farm-Raised Fish Program (ELAP) and the Livestock Indemnity Program (LIP). Fact sheets for these programs can be found at www.fsa.usda.gov; click on NEWSROOM, then FACT SHEETS.

Producers who have suffered a disaster due to the recent severe weather conditions should read the fact sheets and visit their local FSA office to get a quick start on the recovery process.

Both ELAP and LIP Sign-ups require a Notice of Loss filed by the earliest of either:

- 30 calendar days of when the loss is apparent to the participant or
- October 31, 2011

An application for payment must be received no later than January 30.

Emergency Farm Loans

The Farm Service Agency provides emergency loans to help producers recover from production losses and physical losses due to drought, flooding, other natural disasters, or quarantine.

Loan Uses

Emergency loan funds may be used to:

- Restore or replace essential property;
- Pay all or part of production costs associated with the disaster year;

- Pay essential family living expenses;
- Reorganize the farming operation; and
- Refinance certain debts.

Further information and applications for the loan programs described are available at local FSA county offices.

NAP Loss Filing

For losses on crops covered by the Non-insured Crop Disaster Assistance Program (NAP) and crop insurance, you must file a CCC-576 (Notice of Loss) in the FSA County Office within 15 days of the occurrence of the disaster or when losses become apparent. The CCC-576 is used to report failed acreage and prevented planting and may be completed by any producer with an interest in the crop. Timely filing a Notice of Loss is required for all crops including grasses.

If filing for prevented planting, an acreage report and CCC-576 must be filed within 15 calendar days of the final planting date for the crop.

2012 DCP Signup Begins

Enrollment for the 2012 direct and Counter Cyclical Program (DCP) will begin in October and continue through June 1, 2012. USDA urges producers to make use of the eDCP automated website; access at www.eauth.egov.usda.gov. Or, producers can visit any USDA Service Center to complete their 2012 DCP contract.

USDA computes 2012 DCP payments using 85 percent of the commodity base acres, **no** advance direct payment will be disbursed.

Hispanic & Women Farmers/ Black/Native American

A process to resolve the claims of Hispanic and women farmers and ranchers who believe they were discriminated against when seeking USDA farm loans has been established.

If you believe that the United States Department of Agriculture (USDA) improperly denied farm loan benefits to you between 1981 and 2000 because you are Hispanic, or because you are female, you may be eligible to apply for compensation.

Biomass Crop Program

In Oregon up to 7,000 acres of hybrid poplar and 1,000 acres of camelina will be accepted into the Farm Service Agency's Biomass Crop Assistance Program (BCAP) Project Areas 6 and 9 for rental payments based on a soil rental rate plus a 50% incentive.

Enrollment is now open until Sept. 16 and to qualify, producers must first secure a contract with project sponsor ZeaChem, Inc. for poplar or Beaver Biodiesel for processing of the camelina into biofuel.

Created in the 2008 Farm Bill, the BCAP effort is designed to advance domestic energy security, reduce pollution and spur rural economic development and job creation.

Counties eligible for this second phase of BCAP enrollment in Oregon include Jefferson, Klamath, Morrow (poplar only), Umatilla, Union and Wasco. **The**

Willamette Valley is not eligible for BCAP.

Continuous CRP

The Continuous Conservation Reserve Program is a voluntary private lands environmental improvement program that allows participants the opportunity to enroll environmentally sensitive acreages in conservation practices that will reduce soil erosion, improve water and soil quality and provide wildlife habitat and food sources.

Eligible landowners enter into contracts that range from 10 to 15 years in length. In return, the landowners receive annual rental and maintenance payments, incentive payments for certain activities, and cost share for establishment.

To be eligible, participants and acreage must meet certain requirements. Provided the eligibility requirements are met, FSA will automatically accept enrollments of acreage into Continuous CRP. Landowners may enroll in the program at any time during the year. For more information on Continuous CRP enrollments, please contact your local FSA office.

2011 & 2012 SURE ELIGIBILITY

Supplemental Revenue Assistance Payments (SURE) program compensates for production and/or quality losses during times of disaster.

Crops are not required to be harvested on or before September 30, 2011 to maintain SURE eligibility. A loss claim will only trigger after FSA determines that the loss was because of disaster occurring on or before September 30, 2011. Losses that result from disasters that occur after September 30, 2011 will not be eligible for SURE benefits.

The sign-up period for 2011 and 2012 SURE will not begin until after the national average market prices are determined for each respective crop year, which is normally one year after the applicable crop year. For crop year 2010 applications a signup will be offered sometime this fall. Contact your local FSA office for more information.

Rural Youth Loans

FSA makes loans to rural youths to establish and operate income-producing projects in connection with 4-H clubs, FFA and other agricultural groups. Projects must be planned and operated with the help of the organization advisor, produce sufficient income to repay the loan and provide the youth with practical business and educational experience. Loans may not exceed \$5000.

Youth Loan Eligibility Requirements:

- United States citizenship (which includes Puerto Rico, the Virgin Islands, Guam, American Samoa, the Commonwealth of the Northern Mariana Islands) or a legal resident alien
- 10 to 20 years of age
- Comply with FSA's general eligibility requirements
- Reside in a rural area, city or town with a population of 50,000 or fewer people
- Be unable to get a loan from other sources
- Conduct a modest income-producing project in a supervised program of work as outlined above
- Demonstrate capability of planning, managing and operating the project under guidance and assistance from a project advisor. The project supervisor must recommend the project and the loan, along with providing adequate supervision.

Stop by the county office for help preparing and processing the application forms. The FSA staff can help you with questions you may have about a particular program.

Report All Farm Changes

If you have bought, sold or have had rental changes, make sure these are reported to FSA as soon as possible after the changes occur. For farm ownership changes you will need to provide FSA with evidence of the change such as a recorded deed, land contract or real estate tax bill. Landowners and operators must also inform FSA of any cropland changes to the farm. Conversion of cropland to non cropland, a non-agricultural use such as buildings, parking lots, lawns, etc., must be reported to FSA to insure program eligibility.

CHANGE IN FARM LOAN PROGRAM STAFF
