Dear Producer:

This letter is to notify you that the requirements for consolidation of the Converse County FSA office with the Natrona County FSA Office have been completed. Regular farm programs administered out of the Converse County FSA office currently located at 1954 East Richards in Douglas will cease effective July 31, 2007 and all producer records will be transferred to Natrona County.

Producers who desire to have their farm records transferred to a different administrative county office may select any County Office contiguous to Converse County as an alternative. This selection will apply for all programs for the next crop year and subsequent crop years. You may make this change of administrative county office only one time. If you choose to change your administrative County office please notify the Natrona County FSA Office no later than **60 days after the date of this letter**.
