1. PURPOSE

This directive provides guidance on the process, timeline, and procedure for disposing of vehicles identified for removal without replacement by States and offices, through the fiscal year (FY) 2018 vehicle allocation methodology (VAM) survey process.

2. BACKGROUND

The Fleet Support Section, Personal Property Management Branch, is charged with managing the overall operations and performance of the FPAC fleet. One component of optimizing the performance of the fleet is to ensure that the vehicle inventory is maintained and operating efficiently at its optimal size. When deemed necessary, the Fleet Support Section will conduct a VAM study, which includes surveying every vehicle within the inventory to determine its operational necessity. Vehicles that are underutilized and no longer mission-critical are candidates for elimination.

3. PROCEDURES, USDA-OWNED VEHICLES

- a. Attachment A provides a list of the vehicles that States identified for disposal, indicated by an “Eliminate” designation. State offices are asked to identify the owned vehicles assigned to their offices and complete the “FPAC Vehicle Disposal Information Form” (attachment B) for each vehicle listed in attachment A. FPAC fleet operations specialists will provide assistance with completing the form.
- b. States must take multiple photos (interior and exterior from different angles) of each vehicle. Attachment C provides photo examples along with additional instructions.
- c. To ensure that all vehicle disposals are completed successfully, the following must be adhered to:
  - (1) Once attachment B has been completed and the vehicle photos taken, States will upload all to the FPAC Personal Property Management Branch SharePoint site, accessible through the following link:

Instructions on how to carry out the upload can be found within attachment D. The information uploaded will be reviewed and used by the State-assigned fleet specialist to initiate disposal action. Initial steps include posting to the General Services Administration's (GSA's) online property disposal system.

- (2) States must upload all disposal documents to the SharePoint **no later than March 22, 2019**.
- (3) States must review the "Disposal Checklist" (attachment E) and ensure that all applicable steps are followed throughout the disposal process.

#### 4. PROCEDURES, GSA-LEASED VEHICLES

GSA-leased vehicles must be turned in at a GSA marshalling location. FPAC fleet operations specialists will communicate with GSA and provide instructions to States concerning the timing and location for returning vehicles to GSA.

#### 5. VEHICLE DISPOSAL COMPLETION

Vehicle disposals are expected to conclude no later than the summer of 2019. While it is probable that many of the disposals will be final well in advance, certain vehicles such as GSA-leased vehicles may take longer to remove. FPAC fleet operations specialists will be available to provide any requested updates concerning the status of the disposal process.

## Attachment C

In order to accurately depict each vehicle that is being prepared for disposal, we want to show all views of the vehicle.

**\*\*NOTE: The license plate does not need to be removed for the picture, but please cover it with a piece of paper or some other fashion, so it is not included in the picture. GSA will not post license plate numbers, for security reasons.**

The basic digital photos should be taken in good lighting, in .jpg format, clear of obstructions, and from at least the following viewpoints:

1. Driver's side front corner to include driver's side and the front of the vehicle.
2. Passenger side front corner to include the passenger side and the front of the vehicle.
3. Driver's side back corner to include the driver's side and the back of the vehicle.
4. Passenger side back corner to include the passenger side and the back of the vehicle.
5. Engine compartment to include the entire engine.
6. Interior of each section, front seating area, back seating area (if applicable), cargo area of SUV, bed of pick-up truck and/or trunk of sedan.
7. Fuel cap, to confirm fuel type (E-85 or conventional gasoline).
8. Take photos of any specific damage to include dents, body holes, rust, faded or peeling paint, etc.

One .jpg file must be submitted for each picture. Each picture file should simply be named with the tag # and a sequential letter. For example: A280218-a.jpg, A280218-b.jpg, etc.

Please keep picture sizes reasonable, but with sufficient quality for proper online viewing. .5MB – 1MB is a good range for file size for each picture. Usually, if you use the "Large" picture size when sending a picture via email with an iPhone, that will work great.

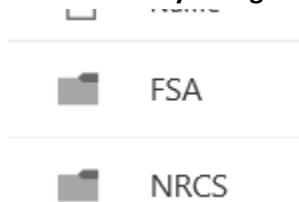
Once you have submitted the information, the vehicle should not be driven due to changes in mileage. Pictures must be uploaded to the SharePoint site in accordance with the instructions given to all customers.

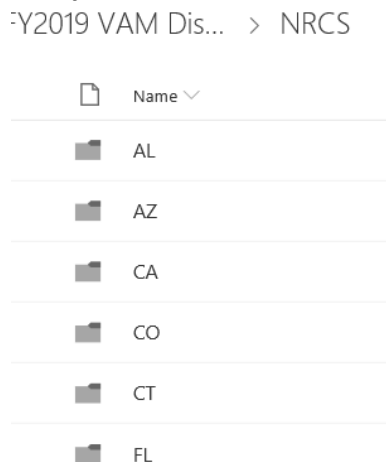

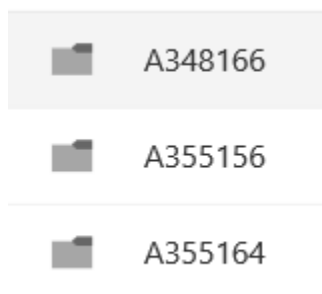

#### III. Coordinate Vehicle Inspection

Any prospective buyer (bidder) of the vehicle may request an inspection while the vehicle is posted for sale on GSA's website. Inspections are at the property custodian's discretion and should be by appointment only. The property custodian or their designated representative should be present during the entire inspection.

- During the inspection, the bidder should be observed closely to ensure vehicle is not tampered with.
- Bidder may start the vehicle, but is not allowed to move it.
- No opinion as to the mechanical condition of the vehicle should be provided to the bidder. However, obvious physical conditions may be disclosed.
- The same information should be given to all bidders.

#### IV. Finalized Transfer or Sale And Coordinate Vehicle Pick Up

##### **If vehicle is transferred to another government agency:**

When the transfer is approved, the PPMB member will forward the form AD-107 or SF-122 directly to the custodian for documentation to support the pick up of the vehicle. Once notified that an agency will receive the vehicle, remove the license plates and all other NRCS equipment from the vehicle. Verify the SF-122/AD-107 brought by the individual who comes to pick up the vehicle. This SF-122/AD-107 is their authorization to pick up the vehicle. Make sure the vehicle description and VIN match the vehicle being picked up. Record the identity of the person picking up the vehicle by copying his/her driver's license or other form of identification. Obtain a signature and date on the SF-122 from the individual picking up the vehicle directly underneath the "Ordering Agency Approval" section. If an AD-107 is being used, the individual should sign and date somewhere in the Item Description section of the form. Once the vehicle is removed, send a scanned copy of the signed SF-122/AD-107 and driver's license to the Fleet Operations Specialist, or to the State Office, if so directed by your State Office. Send the license plates to the address that will be provided to you by your State Office or Fleet Operations Specialist.

##### **If the vehicle is disposed of through GSA Sales:**

If the vehicle is purchased, receive the Purchaser's Receipt from GSA. Please forward a copy of the Purchaser's Receipt to the Fleet Operations Specialist. It is possible that the Fleet Operations Specialist will receive the Purchaser's Receipt instead, and if they do, they will forward to the custodian. Once notified that someone has purchased the vehicle, remove the license plates and all other NRCS equipment from the vehicle. Then coordinate the removal of the vehicle with the purchaser. If the purchaser backs out, or does not remove the vehicle within 10 business days, notify the Fleet Operations Specialist to address the issue with GSA. Verify the Purchaser's Receipt and/or authorization to remove on behalf of the purchaser, if applicable, when the individual comes to claim the vehicle. Record the identity of the person picking up the vehicle by copying his/her driver's license or other form of identification. Obtain a signature on the Purchaser's Receipt from the purchaser or purchaser's authorized representative. Scan a copy of the signed receipt to the Fleet Operations Specialist, or to your State Office if directed by your State Office. Send the license plates to the address that will be provided to you by your State Office or Fleet Operations Specialist.

##### **Note:**

If the buyer doesn't present a Purchaser's Receipt from GSA during vehicle removal, the custodian calls the Fleet Operations Specialist for verification of payment, and a copy of the receipt will be sent to the Custodian.

**VEHICLE DISPOSAL CUSTODIAN CHECKLIST**

Vehicles should not be released to anyone other than the buyer. If the buyer would like someone to pick up the vehicle on their behalf, the property custodian will need written authorization from the buyer. The property custodian must verify photo ID.
