1 Overview

A Background

The Secretary was authorized by the Farm Security and Rural Investment Act of 2002 (the Act) to promulgate and publish in the Federal Register “Uniform Guidelines for Conducting Farm Service Agency County Committee Elections”, if determined necessary after analyzing data in reports required by the Act. The statutory and procedural intent of the guidelines is to ensure fair representation of socially disadvantaged (SDA) groups, such groups being defined in the Consolidated Farm and Rural Development Act (7 U.S.C. 2003(e)), Section 355(e).

The Secretary published proposed uniform guidelines on August 17, 2004, and after a 60 calendar day public comment period, published the final uniform guidelines in the Federal Register on January 18, 2005.

For the 2005 COC election, the Secretary’s office determined that 404 targeted counties were to be designated for special efforts to:

- encourage participation
- attempt to increase SDA representation on COC’s.

The counties were identified using Census of Agriculture data based on SDA operator statistics for each county in the nation. For 2005, the process was refined and identifies those counties where special efforts shall be expended to increase SDA representation on COC’s. For the 2006 election, the same 404 counties are identified for added outreach emphasis.

B Purpose

This notice encourages those 404 County Offices and State Offices in their election outreach and publicity efforts.

2 Action

A Targeted County Office Action

Targeted County Offices shall conduct emphasized outreach and publicity efforts in Local Administrative Areas conducting an election this year to ensure that at least 1 name on the ballot is a member of a group within the definition of SDA producer. The due date for all nominations is August 1, 2006.

B State Office Action

State Offices shall:

- monitor progress to obtain SDA nominees in all targeted County Offices
- provide all assistance necessary to County Offices to obtain SDA nominees with emphasis on targeted County Offices
- ensure that County Offices follow outreach and publicity procedure in Notice AO-1351.
