

Providing Notification of 2009 COC Election Nominations Received and Targeted Counties

1 Overview

A Background

Published in 2002, the Uniform Guidelines for Conducting Farm Service Agency County Committee Elections:

- requires fair representation of SDA producers, such producers being defined in the Consolidated Farm and Rural Development Act (7 U.S.C. 2003(e)), Section 355(e)
- gives the Secretary the right to nominate up to 2 individuals for the slate of COC in the event that no FSA-669A's were filed for a Service Center's COC election.

B Purpose

This notice provides guidance to State Offices and Service Centers for notifying the National Office of the Service Centers that received **no** valid FSA-669A's for the 2009 COC Election. This applies to **all** FSA Service Centers, although the information required differs for targeted and nontargeted Service Centers.

Targeted counties are identified using 2007 Census of Agriculture data based on minority (not SDA) principle operator statistics for each county in the nation. The counties may have changed from those based on the 2002 Census of Agriculture. The number of targeted counties has increased.

A report on nomination activity must be provided to the Secretary by DAFO, so a determination can be made about Secretarial nominations in those Service Centers that received no FSA-669A's or no FSA-669A's naming a minority candidate. It is imperative that **all** counties and States provide this information by the deadlines specified in this notice.

2 Service Center Action

A FSA-669A Deadline

The deadline for all FSA-669A's is **COB August 3, 2009**. Nomination reports shall be e-mailed to the State Office by **COB August 7, 2009**. **Negative reports are required.**

B Nontargeted Service Centers

Nontargeted Service Centers shall notify the State Office by e-mail by the deadline, if **no** FSA-669A's were received for the 2009 COC election.

C Targeted Service Centers

Using FSA-669C (RPT-I-00-CCE-09-06) (Exhibit 2), all targeted Service Centers are required to provide the following notification to the State Office by the deadline:

- a negative report if at least 1 FSA -669A with the name of an eligible minority candidate was received
- no FSA-669A's were received
- no FSA-669A's were received naming a minority candidate.

In multi-county Service Centers, **only** the LAA represented by the actual targeted county is required to have a minority nominee. This requirement may be waived if there is:

- adequate documentation that the Service Center performed extensive COC Election Outreach
- a minority voting member currently serving whose term will carryover into 2010 (alternates and minority advisors do **not** qualify).

In these instances, every effort shall be made to obtain a SDA candidate in place of a minority candidate. This can also apply in single-county Service Centers.

2 Service Center Action (Continued)

C Targeted Service Centers (Continued)

If no FSA-669A's naming a minority candidate were received, also provide the following, if applicable:

- COC that received no FSA-669A's naming a minority candidate has a minority member whose term carries over into 2010
- LAA holding election is **not** where the majority of minority producers in COC jurisdiction reside or have farming operations.

3 State Office Action

A Action

State Offices shall:

- ensure each Service Center submits RPT-I-00-CCE-09-06

Note: Negative reports are required.

- provide a list of the nontargeted Service Centers that did **not** receive any FSA-669A's
- compile the results reported from targeted Service Centers in the State on FSA-669C (Exhibit 2)

Note: Only targeted Service Centers reporting **no** FSA-669A's or **no** FSA-669A's naming a minority candidate received shall be listed on FSA-669C. It is understood that targeted Service Centers not listed on FSA-669C received at least 1 FSA-669A naming an eligible minority candidate.

- e-mail the nontargeted and targeted Service Center FSA-669A results to **deborah.johnson@wdc.usda.gov** by **COB August 14, 2009**.

Note: The list of nontargeted Service Center receiving **no** FSA-669A's shall be in the body of the e-mail, and the targeted Service Center FSA-669A results shall be recorded on FSA-669C and sent as an attachment to the e-mail.

Negative reports are required from States where **all**:

- Service Centers received at least one FSA-669A
- targeted Service Centers received at least one FSA-669A naming a minority candidate.
