**Posting and Publicizing COC 2010 Election Results**

**1 Overview**

**A Background**

Greater emphasis has been placed on the transparency of FSA COC election activities and results. Informing the public about the COC election process continues to be more important as FSA strives to increase diversity and interest in COC elections.

**B Purpose**

This notice provides State and County Offices with instructions to publicize and post 2010 COC election results.

**2 Action**

**A County Office Action**

15-AO, subparagraph 128 B, **requires** County Offices to enter the results of each election into the Reporting for Voters and the Reporting for Candidates Reports. These reports are found at [http://fsaintranet.sc.egov.usda.gov/fsa/FSAIntranet\\_applications.html](http://fsaintranet.sc.egov.usda.gov/fsa/FSAIntranet_applications.html); under “Administrative Applications”, CLICK “COC Elections”. County Offices are **required** to complete the reports within 10 calendar days following counting of ballots and votes. County Offices **must** complete the Reporting for Voters Report and the Reporting for Candidates Report in sequence.

15-AO, subparagraph 128 F, step 9 **requires** that the report be screen-printed and retained as a permanent record of the election. **A clear copy of this screen print shall be posted within 10 calendar days at a location in the County Office where customers and visitors may readily view the election results** (see Exhibit 1). The screen print shall remain on display until **March 1, 2011**.

Election results, including votes received, shall be included in the first county newsletter prepared after the election, if newsletters are sent by the county to producers.
