1 Overview

A Background

Earlier this year the National Office requested all States provide LAA boundary maps and descriptors. The information received from this survey enabled the National Office to complete the digitization of approximately 90 percent of county LAA boundaries and make them available to both internal and external users via the <u>Digital LAA Boundary Locator</u>.

All counties with digital LAA data available in the <u>Digital LAA Boundary Locator</u> are required to discontinue using previous LAA boundary maps and transition to using the digital boundaries maps for all COC functions including the annual review of LAA boundaries. Locations that have not been digitized must complete a review of their existing boundaries and provide the required information to the National Office for creation in the tool.

B Purpose

This notice provides:

- information on using the <u>Digital LAA Boundary Locator</u>
- instructions for submitting digital boundary information to the National Office
- requirement to use digital data for maps
- guidance on the review and approval process for digital LAA boundaries.

2 Digital LAA Boundary Locator Tool

A Using the Digital LAA Boundary Locator Tool

The GIS Digital LAA Boundary Locator is tool is available for both the public and internal users to identify the LAA a particular address is located by using the following search criteria:

- CLICK the "Search" box and enter an address
- CLICK "Use current location" or
- use the map tools to zoom to the area of interest and click on the location within the map.

External users can access the tool on the <u>County Committee Election Website</u> by selecting "Find My LAA".

County Offices users can use this tool to:

- identify a producer's LAA by address and assign them accordingly as required by 15-AO
- search a county or city name within the tool to be directed to an LAA within the identified search criteria
- "clear search location" to click on any LAA surrounding the identified search criteria
- print a PDF version of search results directly from the tool.

Note: The capability to print full county boundaries is not currently available. National Office is working on downloading full county maps and will notify States of where to access once the download is complete.

2 Digital LAA Boundary Locator Tool (Continued)

B LAA Boundary Review Using Digitized Maps

All State and County Offices must complete LAA reviews according to 15-AO, Part 3, Section 3, Establishing LAA's, and Section 4, Maintaining COC and LAA Data. State and County Offices with existing digital boundaries must use digital boundary maps to complete the review.

Note: Native American tribal lands are easily identifiable using the Digital LAA Boundary Locator. Counties with Native American reservation land will consider tribal reservation boundaries in reviewing and establishing LAA's. For more information, see 15-AO and Notice AO-1835.

C Counties With Digital LAA Boundary Maps

Counties that have a digitized map in the tool must use the digital maps to complete the yearly LAA boundary review as required in 15-AO. If the digital boundaries are not accurate or if boundaries have changed, County Offices must complete FSA-582 clearly defining the new boundary and provide an updated map and FSA-582 to the State Office.

State Offices must upload any changes to LAA boundaries along with FSA-582 to the applicable State folder using the <u>LAA Boundary Maps</u> link. Corrections may be submitted using the same link.

State Offices must ensure:

- changes or corrections are clearly defined
- county maps are readable or have a digital equivalent
- FSA-582 descriptors use common names that are easily identifiable for the GIS team.

D Counties Without Digital LAA Boundary Maps

Counties listed in Exhibit 1 have not provided enough information for the National Office to complete the digitization of LAA boundaries. Counties without digitized LAA boundary maps in the <u>Digital LAA Boundary Locator</u> must complete a review of the current LAA boundaries according to 15-AO, Part 3, Section 3 and submit a completed FSA-582 with clear boundary descriptors, along with a copy of the current map, to the State Office for STC approval by **April 1, 2023**.

D Counties Without Digital LAA Boundary Maps (Continued)

State Offices must review FSA-582 and maps to ensure that sufficient information is provided for the National GIS team to identify boundaries. States must ensure that counties use common names and have clearly identifiable descriptors or a digital equivalent. State Offices must upload LAA Boundary Maps and FSA-582 for all counties listed in Exhibit 1 to their applicable State folder using the <u>LAA Boundary Maps</u> link by **May 1, 2023**.

Note: County Offices will not use the upload link. Maps must be reviewed and submitted by the State Office.
