## 1 Overview

### A Background

The OBBBA was enacted on July 4, 2025, and provides ARC and PLC program changes that impact payments for 2025, extends authorization to 2031, and provides an opportunity to allocate new base acres to farms starting with the 2026 program year.

### B Purpose

This notice provides:

- an overview of OBBBA as it relates to the 2025 through 2031 ARC and PLC programs
- basic information on the changes, estimated timeline, and training.

**2 Basic Provisions****A Mandatory Changes**

The following are OBBBA mandatory changes:

- revises the ARC guarantee calculation
- revises the effective reference price calculation
- updates the reference prices
- allocates up to 30 million additional base acres
- extends grass, idle, fallow (G/I/F) designated farms to 2031
- updates the marketing years used to calculate the reference price for Temperate Japonica Rice
- updates the payment rate calculation for ARC-County (ARC-CO)
- increases payment limitation
- provides the higher of ARC-CO or PLC payments for 2025
- requires an election for 2026.

**B Program Updates**

OBBA provides updates for program years 2025 and 2026. No action is needed on behalf of producers to implement program year 2025 changes. The following table lists the effective year for program updates.

- 2/ Seed cotton price is a weighted average of upland cotton and cottonseed prices. Marketing year for upland cotton is August 1 to July 31. Marketing year for cottonseed is August 1 to February 28.

**2 Basic Provisions (Continued)**

**E Base Allocation**

All farms with a cropping history containing a covered commodity in years 2019 through 2023 are eligible for additional base allocation. Additional bases will:

- be allocated based on cropping history
- not exceed effective cropland plus CRP acreage
- be automatic unless an owner opts out.

If subsequent acres are reported on a farm, owners will have the option to designate what covered commodity is used for base allocation. If unassigned base acres are on the farm, an acre-for-acre conversion will be applied before any additional base acre allocation.

**F Program Election**

An election will be required to be made on each farm for program year 2026. Failure to make or agree to an election for a farm in 2026 will result in the election being “defaulted” to the election that was on the farm in 2025, and the farm will be ineligible for payment in 2026.

**3 Timeline and Training**

**A Timeline**

The following items, in specific order, need to be completed to implement OBBBA:

- Farm Records cleanup
- research missing acreage history (history dig)
- subsequent acre designation
- opt-out period
- base allocation
- election and enrollment for 2026.

Each of these items may have a very short turnaround time. It is the goal to have election and enrollment for 2026 completed during this fiscal year. Specific deadlines will be announced for each item listed in future instructions.

**B Training**

The National Office will provide a series of trainings by topic. Training will be recorded and posted for future reference. Training dates and times will be provided when scheduled.
