1 Overview

A Background

The General Services Administration (GSA) requires U.S. Department of Agriculture (USDA) Departmental Agencies to provide information concerning rental for space, structures, facilities, land and building services in support of the Farm and Foreign Agricultural Service's (FFAS) which comprises Farm Service Agency (FSA), Foreign Agricultural Service (FAS), and Risk Management Agency's (RMA) Real Property Space Budget Justification Report on an annual basis in accordance with Office of Management and Budget (OMB) Circular A-11 (2008). OMB uses this information to evaluate the Agency's budget request in the context of cost and personnel changes (e.g., downsizing). General Services Administration (GSA) uses this information to refine its estimates of rental costs. Information being collected will be used in support of the FY 2015 budget cycle.

2 Space Budget Justification

A General Information

Exhibit 54 Verification is a process to convey your space budget information to GSA for GSA-controlled space(s) that FFAS either currently and/or in the future occupies and this lease information is communicated in the Exhibit 54 format. The OMB uses this information to evaluate budget requests for rent in the context of lease and program changes (i.e. downsizing and/or disposal). It is crucial to ensure changes to your GSA-controlled spaces (expansion, reduction, extension, and new lease) are accounted for and reflected in the Exhibit 54 format.

B Exhibit 54 Verification Is Crucial

Rental payments for FFAS's occupancy in the related space are made to a Central Rent Account from GSA. Errors on the Exhibit 54 could result in a shortage or lack of funds, as determined by OMB. The FFAS Budget Offices may then be required to fund the leasing activities from their individual funding accounts. With the current state of budget constraints in USDA, and more presence of GSA at FFAS leased facilities, the careful review and submission of your Real Property Space Budget Justification Report is extremely important.

C FSA State Office Verification Process

The Exhibit 54 Questionnaire is located on FSA's SharePoint website. Your input will be verified and compiled into the official Real Property Space Budget Justification Report and forwarded to the respective Budget Office, USDA's Office of Procurement and Property Management (OPPM) for GSA and OMB reporting and decision making.
