**CED Authority to Approve Certain CRP-1's**

**1 Overview**

**A Background**

Notice CRP-443 provides that all CRP-1's must be approved and entered into the System/36 by September 30, 2003. Given the relatively late announcement of general signup acceptable offers, State and County Offices recently reported complications in approving acceptable CRP signup 26 offers by the September 30, 2003, deadline. Further, some County Offices are reporting excessive workload requirements because of, in part, continuous, CREP, and EQIP offers. State and County Offices are requesting additional time to process and approve signup 26 accepted offers.

**B Purpose**

This notice:

- provides authority to CED's to approve, on a case-by-case basis, certain CRP-1's

**Note:** The effective date of these contracts will be the first of the month after contract approval, similarly to 2-CRP, paragraph 126.

- obsoletes Notice CRP-449.

**2 Approving CRP-1's**

**A CED Authority**

CED's are authorized, on a case-by-case basis, to approve CRP-1's if the offer is a timely filed signup 26 offer, is acceptable, and could not be approved by the September 30, 2003, deadline. Approval authority is limited to those acceptable CRP offers for contracts with an otherwise effective date of October 1, 2003, which could not be approved by September 30, 2003.

**Important:** CED authority to approve CRP-1's ends **COB November 28, 2003.**

### 2 Approving CRP-1's (Continued)

#### B Contracts Approved After September 30, 2003

All CRP-1's must be for a minimum duration of 10 years and shall not exceed 15 years.

Therefore, offers submitted to become effective October 1, 2003, which were not approved by September 30, 2003, may be approved:

- according to Notice CRP-443 by CED between November 1 and November 28, 2003
- for 10 years and 10 months.

**Notes:** The first year annual rental payment will be a prorated payment. The remaining 10 annual rental payments would be made after October 1 of each applicable year.

Offers originally submitted for longer contract lengths shall retain the offered expiration contract date.

County Software Release No. 524 to be released November 10, 2003, allows for contract effective dates other than October 1.

### 3 Action

#### A County Office Action

COC's shall submit all CRP-1's with an effective date of October 1, 2003, not approved by September 30, 2003, to CED for review and approval.

COC is not authorized to approve CRP-1's after COB November 28, 2003.

#### B State Office Action

State Offices shall provide a copy of this notice to the NRCS State Office.

#### C CED Action

CED may approve offers under the authority of this notice from November 1, 2003, through COB November 28, 2003.
