1 Overview

A Background

Notice CRP-913 provided procedure for determining FY 2021 CRP SRR's. States and CREP partners were provided the opportunity to submit alternative rate proposals under that notice, and the alternatives submitted were considered in setting the FY 2021 CRP SRR's.

B Purpose

This notice provides that:

- updated FY 2021 CRP SRR's will be available on December 1, 2020, and effective for offers submitted on or after December 1, 2020
- FY 2021 CRP SRR's will be updated in the Conservation SDMS CRP Soils Database Management System
- FY 2021 CRP SRR's will be posted using SRR posting reports in COLS
- FY 2021 CRP SRR's are not appealable.

2 Posting CRP SRR's

A Availability of FY 2021 CRP SRR's

By **December 1, 2020**, the National Office will post FY 2021 CRP SRR's on FSA CRP statistics website at www.fsa.usda.gov/programs-and-services/conservation-programs/reports-and-statistics/conservation-reserve-program-statistics/index.

Also, by December 1, 2020, FY 2021 CRP SRR's will be available in the Conservation SDMS - CRP Soils Database Management System.

By December 11, 2020, County Offices **must** print and post the FY 2021 CRP SRR's in the County Office using the "SRR Posting Report" option available in COLS, not Conservation SDMS - CRP Soils Database Management System according to 4-CRP, paragraph 150.

Important: The 85 and 90 percent factors for General and Continuous signup,

respectively, are not applied in Conservation SDMS - CRP Soils Database Management System. The applicable factor is applied in COLS and TERRA.

B Effective Date of FY 2021 CRP SRR's

FY 2021 CRP SRR's are effective for all CRP offers received **on or after December 1**, **2020.**

C Appealability of CRP SRR's

CRP SRR's are not appealable.

B County Office Action

County Offices will:

- follow the provisions of this notice
- by December 11, 2020, print and post the FY 2021 CRP SRR's in the County Office
 using the "Posting Report" option available in COLS not Conservation SDMS CRP
 Soils Database Management System according to 4-CRP, paragraph 150.
