**1 Overview**

**A Background**

Notice DAP-226 provided the ending signup dates for the 2003/2004/2005 Crop Disaster Programs (CDP's). Notice DAP-228 provided the ending signup dates for the 2003/2004 Livestock Assistance Program (LAP).

This notice provides the dates on which software will be locked out for the various applications.

**Note:** The lockout of payment software has not been scheduled at this time. A forthcoming notice will provide information on payment software.

**B Purpose**

This notice:

- provides dates the application software will be unavailable for the following disaster programs:
  - 2003/2004 CDP's
  - 2005 CDP
  - Florida Citrus Disaster Program (FCDP)
  - Florida Nursery Disaster Program (FNDP)
  - Florida Vegetable and Tropical Fruit Disaster Program (FVDP)
  - 2003/2004 LAP

**Note:** A date to disable the 2003/2004 American Indian Livestock Feed Program (AILFP) application software has not yet been determined.

### 2 Application Close-Out Dates

#### A 2003/2004 CDP Application Processing

The following options will be disabled from Notice of Loss/Production Application Selection Menu MHADW0 on September 30, 2005:

- option 1, “Noninsurable/Uninsured Losses”
- option 2, “Insured Losses”
- option 4, “Quality Losses”.

**Notes:** Option 3, “Update Enrollment/Approval Dates”, will remain open.

All report options on Report Menu MHADRM will remain open.

#### B 2005 CDP Application Processing

The following options will be disabled from Menu MHADW0 on December 30, 2005:

- option 1, “Noninsurable/Uninsured Losses”
- option 2, “Insured Losses”
- option 4, “Quality Losses”.

**Notes:** Option 3, “Update Enrollment/Approval Dates”, will remain open.

All report options on Menu MHADRM will remain open.

#### C FCDP Application Processing

Option 1, “Loss Application”, will be made unavailable from FCDP Application Menu MHAWW0 on September 9, 2005.

**Note:** Option 2, “Enrollment/Approval Dates”, and option 3, “Print Producer Application”, will remain open.

### 2 Application Close-Out Dates (Continued)

#### D FNDP Application Processing

Option 1, "Loss Application", will be made unavailable from FNDP Application Menu MHAUW0 on September 9, 2005.

**Note:** Option 2, "Enrollment/Approval Dates", and option 3, "Print Producer Application", will remain open.

#### E FVDP Application Processing

Option 1, "Loss Application", will be made unavailable from FVDP Application Menu MHAVW0 on September 9, 2005.

**Note:** Option 2, "Enrollment/Approval Dates", and option 3, "Print Producer Application", will remain open.

#### F Virginia Crop Loss Application Processing

The following options will be disabled from Menu MHADW0 on August 12, 2005:

- option 1, "Noninsurable/Uninsured Losses"
- option 2, "Insured Losses"
- option 4, "Quality Losses".

**Notes:** Option 3, "Update Enrollment/Approval Dates", will remain open.

All report options on Menu MHADRM will remain open.

#### G 2003/2004 LAP Application Processing

The process to complete or modify application data on a 2003 or 2004 LAP application will be disabled on September 30, 2005. Users will still be able to:

- enter signature dates
- enter approval/disapproval dates
- run reports.

**Note:** County Offices shall run the reports in 4-DAP (Rev. 1), paragraph 104 to ensure that appropriate action is taken on all applications currently filed. As of August 3, 2005, action has not been taken on over half of the applications filed in the nation.

## Notice DAP-232

### 3 County Office Action

#### A Action

County Offices shall ensure that the following actions are taken before the applicable programs application closing date:

- **all** application data is loaded in the system

**Notes:** This includes applications that:

- are in appeal status
- were filed on manual application and have not been loaded in the system
- have been disapproved by COC.

The payment software for CDP, LAP, and AILFP is designed to determine the most beneficial year based on the program provisions. County Offices shall take action on all applications filed and record the approval or disapproval in the automated system, as applicable.

- subsidiary files, especially for 2003, are updated properly for joint operations, entities, combined producers, payment limitation allocations, and eligibility data by September 16, 2005
- farm maintenance files, especially for 2003, are updated properly by September 16, 2005.
