For: State and County Offices

Reduction of EFRP Cost Share (C/S) Payment Because of Income Derived From Salvaged Debris

Approved by: Deputy Administrator, Farm Programs



1 Overview

A Background

The EFRP regulation at 7 CFR §701.226, maximum financial assistance, provides that an EFRP participant will not receive more than 75 percent of the lesser of the participant's total **actual cost** or of the total allowable costs to perform the practice.

B Purpose

This notice provides:

- guidance on income derived from debris
- examples of reduced C/S payments.

2 Reduction Provision

A C/S Payment Reduction

1-EFRP also states that C/S assistance will not exceed 75 percent of the participants actual cost to perform the practice **and** defines actual cost as net or out-of-pocket costs.

Income derived from any aspect of performing the approved EFRP practices will reduce the participant's out-of-pocket expenses and thus, the amount of C/S assistance.

3 Examples of C/S Reductions

A Example - Exchange for Services

- Restoration Plan includes woody material debris removal and natural regeneration.
- Approved for \$50,000 C/S.
- Contracts restoration services.
- Contractor agrees to perform all needed debris removal in exchange for the debris.
- Since no other activities are planned – the out of pocket cost incurred is zero.
- No EFRP C/S is earned.

B Example - Landowner Performs Restoration Work

- Forest Restoration Plan includes debris removal, site prep, and tree planting.
- Approved for \$100,000 C/S.
- Landowner performs all debris removal and site prep.
- Maintains a log of time spent and equipment used to do those practices.
- Some of debris is valuable and sold for saw logs, pulp wood and firewood for \$30,000.
- Work logs, records, invoices and sales documentation include:
 - landowner labor - \$6,000
 - hired labor - \$2,000
 - landowner equipment - \$4,000
 - equipment rental - \$3,000
 - contracted tree planting - \$35,000
 - salvaged woody material sales - \$30,000.
- C/S is calculated as: $\$20,000 (\$50,000 \text{ landowner cost} - \$30,000 \text{ debris income}) \times .75 = \$15,000$.

C Example - Landowner Contracts Restoration Work

- Restoration Plan includes debris removal, site prep, tree planting, and wildlife habitat restoration.
- Approved for \$100,000 C/S.
- Contractor agrees to do all restoration work for \$150,000 and will act as an agent to sell salvage debris for a 30 percent commission.
- Salvaged material was sold as logs, pulp wood, and firewood for \$60,000:
 - landowner share - \$42,000
 - contractor share - \$18,000.
- Contractor provides detailed bill for \$150,000 and receipts for sales \$60,000.
- C/S is calculated as: $\$108,000 (\$150,000 \text{ invoice amount} - \$42,000 \text{ landowner share of salvage}) \times .75 = \$81,000$.

3 Examples of C/S Reductions (Continued)

D Example - Landowner Contracts Services

- Restoration Plan includes debris removal, NIPF road repair, site prep, tree planting and wildlife habitat restoration.
- Approved for \$100,000 C/S.
- Contractor agrees to perform all needed restoration for \$150,000.
- Contractor will salvage woody debris for his own use – no payment to the producer.
- Detailed invoice is provided for \$150,000.
- C/S is calculated as: $\$150,000 \text{ (invoice amount)} \times .75 = \$112,500$, which is reduced to the approved amount of \$100,000.
