1 Overview

A Background

FY 2003 allocations of direct and guaranteed farm ownership (FO) and operating loans (OL) for individual States have been computed according to FmHA Instruction 1940-L. Individual State allocations are in Exhibit 1.

- provides information on allocations available in all loan programs
- establishes the total FY 2003 funding levels available to each State
- provides requirements for obtaining National Reserve Funds.

2 Loan Programs Not Funded or Not Allocated to States

A Programs Not Funded

The following FLP are not funded in FY 2003:

- Grazing Association
- Guaranteed Farm Ownership with Interest Assistance
- Irrigation and Drainage
- Direct Soil and Water
- Guaranteed Soil and Water
- Credit Sales of Acquired Properties
- Special Apple Loan Program.

B Programs Not Allocated to States

The following FLP are not allocated to States.

Emergency Loans - The FY 2003 appropriations bill (Pub. L. 108-7) does not provide funding authority. However, a carryover of unused funds from FY 2002 totaling \$228.9 million is available for use in FY 2003. Loans may be obligated as loans are approved in designated areas.

Indian Tribal Land Acquisition Loans - Control of funds is being retained in the National Office. States should request funds from the Director, LMD, by FAX at 202-690-1117. Funding authority for FY 2003 is \$1,987,000.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$1,000,000, \$500,000, \$3,000,000, and \$500,000, respectively.

A administrative allocation has been made to each State. Under the administrative allocation, each State received the same percentage of the FY 2003 initial allocation as they received of the initial FY 2002 allocation.

The FY 2003 appropriations bill provides funding authority of \$601 million. A carryover of unused funds from FY 2002 totaling \$5.2 million is also available for use in FY 2003.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$400,000, \$400,000, \$3,336,000, and \$400,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received 75 percent of their average obligations for FY's 2002 and 2001.

Funding authority provided in the FY 2003 appropriations bill is \$1,688,950,000. A carryover of unused funds from FY 2002 totaling \$20.775 million is also available for use in FY 2003.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to each of these jurisdictions was \$400,000.

An administrative allocation has been made to each State. Under the administrative allocation, each State received 60 percent of their average obligations for FY's 2002 and 2001.

Funding authority provided in the FY 2003 appropriations bill is \$397,400,000. A carryover of unused funds from FY 2002 totaling \$3.919 million is also available for use in FY 2003.

Funding authority provided in the FY 2003 appropriations bill is \$993,500,000. A carryover of unused funds from FY 2002 totaling \$48.427 million is also available for use in FY 2003.

- amount of the loan
- category of the loan (non-beginning or beginning farmer, socially disadvantaged (SDA) or non-SDA)
- for direct loans, date of initial application
- for guaranteed loans, date of complete application.
