2 Loan Programs Not Funded or Not Allocated to States

A Programs Not Funded

The following FLP are **not** funded in FY 2010:

- Credit Sales of Acquired Properties
- Direct Soil and Water
- Grazing Association
- Guaranteed Farm Ownership with Interest Assistance
- Guaranteed Soil and Water
- Irrigation and Drainage.

B Programs Not Allocated to States

The following FLP are **not** allocated to States.

Emergency Loans - The FY 2010 appropriations bill (Pub. L. 111-80) does not provide funding authority. However, a carryover of unused funds from FY 2009 totaling \$217 million is available for use in FY 2010. Loans may be obligated as loans are approved in designated areas.

Indian Tribal Land Acquisition Loans - Control of funds is being retained in the National Office. States should request funds from the Director, LMD, by FAX to 202-690-1117. Funding authority for FY 2010 is \$3.94 million.

Guaranteed OL Unsubsidized - Funding authority for FY 2010 is \$1.5 billion. All funds will be retained under National Office control. Loans may be obligated as loans are approved.

Guaranteed OL With Interest Assistance - Funding authority for FY 2010 is \$170 million. All funds will be retained under National Office control. Loans may be obligated as loans are approved.

Guaranteed FO - Funding authority for FY 2010 is \$1.5 billion. All funds will be retained under National Office control. Loans may be obligated as loans are approved.

A Funded Programs

The FY 2010 appropriations bill establishes funding levels for the following programs:

- Direct OL (see subparagraph B)
- Direct FO (see subparagraph C).

B Direct OL

The FY 2010 funding for Direct OL is as follows.

Total Available	\$1,002,109,000
Less National Reserve	- 72,910,000
Less Administrative Allocation	- 929,199,000

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$400,000, \$300,000, \$2,200,000, and \$300,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received their average obligations for FY's 2009 and 2008.

The FY 2010 appropriations bill provides funding authority of \$1 billion. A carryover of unused funds from FY 2009 totaling \$2,109,000 is also available for use in FY 2010.

C Direct FO

The FY 2010 funding for Direct FO is as follows.
