**1 Overview**

**A Background**

2024 LIP signup began on January 1, 2024. LIP provides separate payment rates for eligible livestock owners and eligible contract growers. Payment rates for eligible livestock and contract grower rates are included in this notice.

**B Purpose**

This notice:

- provides updated 2024 LIP per head payment rates, by livestock category, for eligible livestock owners
- informs State and County Offices that payment rates for livestock owners are based on 75 percent of the average fair market value, as determined by CCC, for the specific livestock category.

**2 2024 LIP**

**A Payment Rates**

2024 LIP Payment Rates are established through the Economic and Policy Analysis Division (EPAD) as required in 7 CFR Part 1416.306, Subpart (b). These rates have been loaded into the LIP software which accommodates correct 2024 payment calculations for producers participating in 2024 LIP.
