1 Approval Policy for CCC-633 EZ

A Background

Notice LP-2130 provided the revised CCC-633 EZ and established general LDP policies for the 2009 and subsequent crop years.

B Purpose

This notice provides guidance to County Offices on which CCC-633 EZ version should be accepted from producers declaring intention to receive LDP benefits (page 1) and requesting LDP's (page 2, 3, or 4).

IF producer submits...	AND a request for an LDP payment on CCC-633 EZ, page 2, 3, or 4, as applicable, is received...	THEN County Offices shall...
CCC-633 EZ (09-05-07), page 1 on or before August 11, 2009	on or before August 11, 2009	approve/disapprove the request for payment.
	August 12, 2009, through October 31, 2009 <u>1/</u>	approve/disapprove the request for payment on either of the following versions: <ul style="list-style-type: none"> • CCC-633 EZ (07-31-09) • CCC-633 EZ (09-05-07).
CCC-633 EZ (07-31-09), page 1 on or after August 12, 2009 <u>2/</u>		only accept requests for payment using the CCC-633 EZ (07-31-09) version.

1/ Producers submitting an LDP request on either version of CCC-633 EZ (page 2, 3, or 4) **after** October 31, 2009, will **not** have to submit an LDP agreement on CCC-633 EZ (07-31-09), page 1, if on or before August 11, 2009, CCC-633 EZ (09-05-07), page 1 was already filed.

2/ Accept **only** CCC-633 EZ (07-31-09), page 1 on or after August 12, 2009.
