**1 Overview**

**A Background**

Reviews are to be conducted annually of farming operations of program participants to determine compliance with applicable statutes and regulations for payment eligibility. Selections of farming operations for 1998-2002 compliance review purposes have been provided to State Offices. With the exception of 2002, deadlines have passed for completing 1998-2001 reviews and submitting appropriate information with PA-122R and CCC-502-EYR.

**B Purpose**

This notice:

- provides current status of compliance reviews
- reminds State Offices of established deadlines for completing reviews
- requires SED's to provide information to DAFP about EYR activity.

### 2 General Information

#### A DAFP Selections

DAFP selections of farming operations for 1998-2002 for each State and the record of EYR completion is shown in Exhibit 1. Also shown are States that did **not** receive DAFP selections for 1998-2002. The established deadlines for completing EYR's were previously included with each of the selection listings.

#### B Deadline

The deadline for completing 2002 reviews is no later than **March 31, 2004**.

### 3 Action

#### A SED and STC Action

SED's and STC's shall:

- review Exhibit 1
- update the status of completed review(s)
- provide appropriate EYR reports and information according to 1-PL, paragraph 707.

#### B State Office Action

States Offices that have **not** timely completed EYR's, SED's shall provide a written response to DAFP that must include:

- valid reasons for incomplete reviews
- plans for timely completion
- STC deadline for completing EYR's.
