### Administrator's Physical Loss Notifications N1820

On April 28, 2025, Farm Service Agency Administrator, William L. Beam, signed an Administrator's Physical Loss Notification due to the excessive rain, flash flooding, flooding, hail, high winds, lightning, and tornadoes that affected several counties in Arkansas from March 30, 2025, and continuing.

#### **Administrator's Physical Loss Notification N1820:**

Cause: Excessive Rain, Flash Flooding, Flooding, Hail, High Winds, Lightning, and Tornadoes

Disaster Start Date: March 30, 2025

Disaster End Date: Continuing

Last Day to Apply for EM Loan: December 29, 2025
