



USDA Announces Availability of Low-Interest Physical Loss Loans for Producers Affected by Natural Disasters

Emergency Designation | South Dakota | May 29, 2025

South Dakota

Physical loss loans through the United States Department of Agriculture's (USDA) Farm Service Agency (FSA) can help producers repair or replace damaged or destroyed physical property essential to the success of the agricultural operation, including livestock losses. Examples of property commonly affected include essential farm buildings, fixtures to real estate, equipment, livestock, perennial crops, fruit and nut bearing trees, and harvested or stored crops and hay.

Application Deadline: Jan. 23, 2026

Primary Counties Eligible:

- **North Dakota:** Grant

Contiguous Counties Also Eligible:

- **North Dakota:** Adams, Hettinger, Morton, Sioux, and Stark

Triggering Disaster #2

Impacted Area: North Dakota

Triggering Disaster: Wildfire and High Winds that occurred April 12, 2025

Application Deadline: Jan. 23, 2026

Primary Counties Eligible:

- **North Dakota:** Burleigh and Sheridan

Contiguous Counties Also Eligible:

- **North Dakota:** Emmons, Kidder, McHenry, McLean, Morton, Oliver, Pierce, and Wells

Triggering Disaster #3

Impacted Area: North Dakota

Triggering Disaster: Wildfire and High Winds that occurred on March 9, 2025

Application Deadline: Jan. 23, 2026

Primary Counties Eligible:

- **North Dakota:** Burleigh

Contiguous Counties Also Eligible:

- **North Dakota:** Emmons, Kidder, McLean, Morton, Oliver, and Sheridan

Triggering Disaster #4

Impacted Area: North Dakota

Triggering Disaster: Wildfire and High Winds that occurred on April 9 through April 14, 2025

Application Deadline: Jan. 23, 2026

Primary Counties Eligible:

- **North Dakota:** Adams

Contiguous Counties Also Eligible:

- **North Dakota:** Bowman, Grant, Hettinger, Sioux, and Slope
- **South Dakota:** Corson, Harding, and Perkins
