



USDA Announces Availability of Low-Interest Physical Loss Loans for Producers Affected by Natural Disasters

Emergency Designation | Tennessee | July 30, 2025

Physical loss loans through the United States Department of Agriculture's (USDA) Farm Service Agency (FSA) can help producers repair or replace damaged or destroyed physical property essential to the success of the agricultural operation, including livestock losses. Examples of property commonly affected include essential farm buildings, fixtures to real estate, equipment, livestock, perennial crops, fruit and nut bearing trees, and harvested or stored crops and hay.

Triggering Disaster: Tornado, excessive rain, flash flood, hail and high winds that occurred on April 2 through April 6, 2025

Application Deadline: March 24, 2026

8. Administrator Physical Loss Notification - N1853

Impacted Area: Tennessee

Triggering Disaster: Excessive rain, flash flooding, high winds, and lightning that occurred on April 2

through April 6, 2025

Application Deadline: March 24, 2026

Primary Counties Eligible:

- Tennessee: Putnam

Contiguous Counties Also Eligible:

- Tennessee: Cumberland, DeKalb, Fentress, Jackson, Overton, Smith, White

9. Administrator Physical Loss Notification - N1854

Impacted Area: Tennessee

Triggering Disaster: Excessive rain, flash flood, hail, high winds, and lightning that occurred on April 2 through April 6, 2025

Application Deadline: March 24, 2026

- Tennessee: Van Buren, White

- Tennessee: Bledsoe, Cumberland, DeKalb, Putnam, Sequatchie, Warren

10. Administrator Physical Loss Notification - N1855

Impacted Area: Tennessee, Kentucky

Triggering Disaster: Tornado that occurred on April 2 through April 3, 2025

Application Deadline: March 24, 2026

Primary Counties Eligible:

- **Tennessee: Weakley**

Contiguous Counties Also Eligible:

- **Tennessee: Carroll, Gibson, Henry, Obion**
- **Kentucky: Graves, Hickman**

11. Administrator Physical Loss Notification - N1856

Impacted Area: Tennessee

Triggering Disaster: Tornadoes and high winds that occurred on April 2 through April 6, 2025

Application Deadline: March 24, 2026

Primary Counties Eligible:

- **Tennessee: Wilson**

Contiguous Counties Also Eligible:

- **Tennessee: Cannon, Davidson, DeKalb, Rutherford, Smith, Sumner, Trousdale**

12. Administrator Physical Loss Notification - N1857

Impacted Area: Tennessee, Kentucky

Triggering Disaster: Tornado, excessive rain, flash flooding, and high winds that occurred on March 26 and continuing

Application Deadline: March 24, 2026

Primary Counties Eligible:

- **Tennessee: Henry, Humphreys**

Contiguous Counties Also Eligible:

- **Tennessee: Benton, Carroll, Dickson, Hickman, Houston, Perry, Steward, Weakley**
- **Kentucky: Calloway, Graves**
