



## USDA Announces Availability of Low-Interest Physical Loss Loans for Minnesota Producers Affected by High Winds, Hail, Tornado, Excessive Rain, and Flash Flooding

**Emergency Designation | Minnesota | August 14, 2025**

Minnesota

[Physical loss loans](#) through the United States Department of Agriculture's (USDA) Farm Service Agency (FSA) can help producers repair or replace damaged or destroyed physical property essential to the success of the agricultural operation, including livestock losses. Examples of property commonly affected include essential farm buildings, fixtures to real estate, equipment, livestock, perennial crops, fruit and nut bearing trees, and harvested or stored crops and hay.

**Triggering Disaster 1:** High Winds that occurred on May 15, 2025 (N1865)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Douglas

**Contiguous Counties Also Eligible:**

**Triggering Disaster 2:** High Winds that occurred on May 19, 2025, through May 20, 2025 (N1866)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Cottonwood, Jackson

**Contiguous Counties Also Eligible:**

**Minnesota:** Brown, Martin, Murray, Nobles, Redwood, Watonwan

**Iowa:** Dickinson, Emmet, Osceola

**Triggering Disaster 3:** Hail and high winds that occurred on June 2, 2025 (N1867)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Renville, Stevens

**Contiguous Counties Also Eligible:**

**Minnesota:** Big Stone, Brown, Chippewa, Douglas, Grant, Kandiyohi, McLeod, Meeker, Nicollet, Pope, Redwood, Sibley, Swift, Traverse, Yellow Medicine

**Triggering Disaster 4:** High winds that occurred June 2, 2025 (N1868)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Brown, Pope

**Contiguous Counties Also Eligible:**

**Minnesota:** Blue Earth, Cottonwood, Douglas, Grant, Kandiyohi, Nicollet, Redwood, Renville, Stearns, Stevens, Swift, Watonwan

**Triggering Disaster 5:** Tornado that occurred on June 16, 2025 (N1869)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Cass, Crow Wing

**Contiguous Counties Also Eligible:**

**Minnesota:** Aitkin, Beltrami, Hubbard, Itasca, Mille Lacs, Morrison, Todd, Wadena

**Triggering Disaster 6:** Excessive rain and flash flooding that occurred on June 12, 2025, through June 14, 2025 (N1870)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Big Stone

**Contiguous Counties Also Eligible:**

**Minnesota:** Lac qui Parle, Stevens, Swift, Traverse

**South Dakota:** Grant, Roberts

**Triggering Disaster 7:** High winds that occurred on June 20, 2025, through June 21, 2025 (N1871)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Becker, Beltrami, Clearwater, Hubbard, Mahnomen, Norman

**Contiguous Counties Also Eligible:**

**Minnesota:** Cass, Clay, Itasca, Koochiching, Lake of the Woods, Marshall, Otter Tail, Pennington, Polk, Roseau, Wadena

**North Dakota:** Cass, Traill

**Triggering Disaster 8:** Hail and high winds that occurred on June 19, 2025, through June 20, 2025 (N1872)

**Application Deadline:** April 13, 2026

**Primary Counties Eligible:** Douglas, Stearns, Todd

**Contiguous Counties Also Eligible:**

**Minnesota:** Benton, Cass, Grant, Kandiyohi, Meeker, Morrison, Otter Tail, Pope, Sherburne, Stevens, Wadena, Wright
