



USDA Designates Two Idaho Counties as Primary Natural Disaster Areas Emergency Designation | Idaho | August 29, 2025

Idaho

This Secretarial natural disaster designation allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through [emergency loans](#). Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability.

According to the [U.S. Drought Monitor](#), these counties suffered from a drought intensity value during the growing season of 1) D2 Drought-Severe for 8 or more consecutive weeks or 2) D3 Drought-Extreme or D4 Drought-Exceptional.

Impacted Area: Montana and Idaho

Triggering Disaster: Drought (Fast Track)

Application Deadline: April 13, 2026

- **Montana:** Lincoln

Contiguous Counties Also Eligible:

- **Idaho:** Bonner and Boundary

- **Montana:** Flathead and Sanders

Triggering Disaster #4 - S6042

Impacted Area: Utah, Idaho, Colorado, and Wyoming

Triggering Disaster: Drought (Fast Track)

Application Deadline: April 13, 2026

Primary Counties Eligible:

- **Utah:** Daggett, Rich and Summit

Contiguous Counties Also Eligible:

- **Idaho:** Bear Lake and Franklin
- **Colorado:** Moffat
- **Utah:** Cache, Duchesne, Morgan, Salt Lake, Uintah, Wasatch and Weber
- **Wyoming:** Lincoln, Sweetwater, and Uinta
