



USDA Announces Availability of Low-Interest Physical Loss Loans for Minnesota Producers Affected by High Winds, Excessive Rain, Hail, and Tornado

Emergency Designation | Iowa | November 24, 2025

Iowa Counties Included as Contiguous

[Physical loss loans](#) through the United States Department of Agriculture's (USDA) Farm Service Agency (FSA) can help producers repair or replace damaged or destroyed physical property essential to the success of the agricultural operation, including livestock losses. Examples commonly affected property includes essential farm buildings, fixtures to real estate, equipment, livestock, perennial crops, fruit and nut bearing trees, and harvested or stored crops and hay.

Application Deadline: May 29, 2026

Application Deadline: May 29, 2026

Triggering Disaster 4: Excessive rain, flash flood, hail, and high winds that occurred July 27 - 28, 2025 (N1893)

Application Deadline: May 29, 2026

Triggering Disaster 5: Excessive rain and high winds that occurred July 27 - 29, 2025 (N1894)

Application Deadline: May 29, 2026

Triggering Disaster 6: Flash flood, excessive rain, high winds, and hail that occurred on July 27, 2025 (N1895)

Application Deadline: May 29, 2026

Triggering Disaster 9: Tornado that occurred June 25 - June 26, 2025 (N1898)

Triggering Disaster 10: Excessive Rain that occurred June 26 - June 27, 2025 (N1899)

Application Deadline: July 24, 2026

Triggering Disaster 11: Lightning and hail that occurred on June 28, 2025 (N1900)

Application Deadline: July 24, 2026

Triggering Disaster 12: Tornado that occurred June 30, 2025 (N1901)

Application Deadline: July 24, 2026

Triggering Disaster 13: High winds that occurred on July 2, 2025 (N1902)

Application Deadline: July 24, 2026
