

## USDA Designates Eight South Carolina Counties as Primary Natural Disaster Areas

Emergency Support to Producers in Surrounding Counties/Border States Also Available

**WASHINGTON, March 18, 2020** - Agriculture Secretary Sonny Perdue designated eight South Carolina counties as primary natural disaster areas. Producers in Anderson, Calhoun, Greenville, Lexington, Orangeburg, Pickens, Richland, and Spartanburg counties who suffered losses due to recent drought may be eligible for U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) emergency loans.

This natural disaster designation allows FSA to extend much-needed emergency credit to producers recovering from natural disasters. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation or the refinance of certain debts.

Producers in the contiguous South Carolina counties of Abbeville, Aiken, Bamberg, Barnwell, Berkeley, Cherokee, Clarendon, Colleton, Dorchester, Fairfield, Kershaw, Laurens, Newberry, Oconee, Saluda, Sumter, and Union, along with Elbert and Hart counties in Georgia, and Henderson, Polk, Rutherford, and Transylvania counties in North Carolina, are also eligible to apply for emergency loans.

The deadline to apply for these emergency loans is Nov. 7, 2020.

FSA will review the loans based on the extent of losses, security available and repayment ability.

FSA has a variety of additional programs to help farmers recover from the impacts of this disaster. FSA programs that do not require a disaster declaration include: <a href="Emergency Assistance for Livestock">Emergency Assistance for Livestock</a>, <a href="Honeybees and Farm-Raised Fish Program">Honeybees and Farm-Raised Fish Program</a>; <a href="Emergency Conservation Program">Emergency Conservation Program</a>; <a href="Livestock Forage">Livestock Forage</a></a> <a href="Disaster Program">Disaster Program</a>; <a href="Livestock Indemnity Program">Livestock Indemnity Program</a>; <a href="Operating and Farm Ownership Loans">Operating and Farm Ownership Loans</a>; and the <a href="Tree">Tree</a> <a href="Assistance Program">Assistance Program</a>.
