USDA Announces Cooperative Agreements for Community Compost and Food Waste Reduction

COLLEGE STATION, Texas, May 17, 2021 – The U.S. Department of Agriculture (USDA) today announced the availability of up to \$2 million for local governments to host Community Compost and Food Waste Reduction (CCFWR) pilot projects for fiscal year 2021. The cooperative agreements support projects that develop and test strategies for planning and implementing municipal compost plans and food waste reduction plans and they are part of USDA's broader efforts to support urban agriculture.

USDA's Office of Urban Agriculture and Innovative Production (Office) will accept applications on <u>Grants.gov</u> until 11:59 p.m. Eastern Time on July 16, 2021. Projects should span two years with a start date of September 25, 2021 and completion date of September 25, 2023.

"Finding ways to turn food waste into nutrient rich compost is a win-win for farmers, communities and the environment," said Eddie Trevino, Acting State Executive Director in Texas. "The level of enthusiasm and creativity communities are putting towards this kind of problem solving is inspiring, and USDA is proud to support it."

Details

Cooperative agreements support projects led by local governments that:

- Generate compost.
- Increase access to compost for agricultural producers.
- Reduce reliance on and limit the use of fertilizer.
- Improve soil quality.
- Encourage waste management and permaculture business development.

- Increase rainwater absorption.
- Reduce municipal food waste.
- Divert food waste from landfills.

USDA's Natural Resources Conservation Service (NRCS) will provide assistance for conservation related activities.

Priority will be given to projects that anticipate or demonstrate economic benefits, incorporate plans to make compost easily accessible to farmers, including community gardeners, integrate other food waste strategies, including food recovery efforts and collaborate with multiple partners.

This is the second year the Office of Urban Agriculture and Innovation Production offered this grant opportunity. Examples of previous projects include:

- The City of Lawrence Municipal Services & Operations and Just Food in Douglas County,
 Kansas are partnering on a food waste collection pilot to incorporate into its yard waste compost
 facility; establish a farm gleaming program to provide produce to clients of Just Food, Lawrence
 Community Sheltet, and Sunrise project. The project also seeks to encourage farmer and
 gardener access to the composting facility.
- The City of Fayetteville, Arkansas is piloting the Mobile Food Waste Collection and Compost Education Program to support the purchase and development of mobile Food Waste Recovery Trailer that will eb transported to events and festivals to collect food waste and educate residents. The City ill provide residents with 3.5-gallon food waste containers for the home, allowing waste to be dropped off at several sites. An extensive food waste composting education program will include a full-time educator to provide information, instruction, and advice on theories and methods of organic composting.

Webinar

A pre-recorded webinar will provide an overview of the cooperative agreements' purpose, project types, eligibility and basic requirements for submitting an application. The webinar will be posted at farmers.gov/urban.
