



## USDA Designates 17 Pennsylvania Counties as Primary Natural Disaster Areas

News Release | New York | February 14, 2023

This Secretarial natural disaster designation allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through [emergency loans](#). Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation or the refinance of certain debts. FSA will review the loans based on the extent of losses, security available and repayment ability.

**Triggering Disaster #1:** Drought that occurred during May 15, 2022, through September 20, 2022

**Application Deadline:** Oct. 2, 2023

**Application Deadline:** Oct. 2, 2023
