# Federal Emergency Management Agency Designates 21 Florida Counties as Primary Natural Disaster Areas Due to Hurricane Idalia

Contiguous counties in Florida and Georgia are also eligible for assistance

This Presidential disaster declaration allows the United States Department of Agriculture (USDA) Farm Service Agency (FSA) to extend much-needed emergency credit to producers recovering from natural disasters through <a href="mailto:emergency loans">emergency loans</a>. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation, or to refinance certain debts. FSA will review the loans based on the extent of losses, security available, and repayment ability.

The following disaster designations have been amended to as follows:

Impacted Area: Florida

**Triggering Disaster 1:** Hurricane Idalia that occurred 08/27/2023 to 09/04/2023

Application Deadline: May 1, 2024

Primary Counties Eligible: Citrus, Dixie, Hamilton, Lafayette, Levy, Suwannee, and Taylor

**Contiguous Counties Also Eligible:** 

Florida: Alachua, Columbia, Gilchrist, Hernando, Jefferson, Madison, Sumter

Georgia: Brooks, Echols, Lowndes

Disaster 1, Amendment: Hurricane Idalia that occurred 08/27/2023 to 09/04/2023

Application Deadline: May 1, 2024

Primary Counties Eligible: Columbia, Gilchrist, Hernando, Jefferson, Madison, and Pasco

#### **Contiguous Counties Also Eligible:**

Florida: Alachua, Baker, Citrus, Dixie, Hamilton, Hillsborough, Lafayette, Leon, Levy, Pinellas, Polk,

Sumter, Suwannee, Taylor, Union, Wakulla

Georgia: Brooks, Clinch, Echols, Lowndes, and Thomas

Application Deadline: May 3, 2024

**Primary Counties Eligible:** Pinellas

**Contiguous Counties Also Eligible:** 

Florida: Hillsborough, Manatee, and Pasco

Disaster 1, Amendment: Hurricane Idalia from 08/27/2023 to 09/04/2023

**Application Deadline**: May 9, 2024

Primary Counties Eligible: Manatee and Sarasota

**Contiguous Counties Also Eligible:** 

Florida: Charlotte, DeSoto, Hardee, Hillsborough, Pinellas, and Polk

Disaster 1, Amendment: Hurricane Idalia 08/27/2023-09/04/2023

Application Deadline: June 3, 2024

Primary Counties Eligible: Baker, Charlotte, Duval, Hillsborough, and Nassau

**Contiguous Counties Also Eligible:** 

Florida: Bradford, Clay, Columbia, DeSoto, Galdes, Hardee, Hendry, Highlands, Lee, Manatee,

Pasco, Pinellas, Polk, St. Johns, Sarasota, and Union

Georgia: Camden, Charlton, Clinch, and Ware
