The Department of Agriculture's Commodity Credit Corporation announced the competitiveness payment program payment rate in effect from 12:01 a.m., Eastern Time, Friday, May 15, 2020, through midnight, Eastern Time, Thursday, May 21, 2020, at 4:00 p.m., Eastern Time.

ELS competitiveness payments are provided whenever, for 4 consecutive weeks, the lowest Friday through Thursday average adjusted price quotation for foreign growths (LFQ) is less than the Friday through Thursday average price quotation for U.S. Pima cotton, CFR Far East (USPFE); and the adjusted LFQ is less than 113 percent of the current 2019 crop year loan level for ELS cotton grade 2, staple 46, micronaire 3.5 or higher, strength 37.5 grams per tex and above (95.75 cents per pound). Future payments will be established if price conditions warrant. Relevant data for the ELS competitiveness program follow:

The adjusted LFQ = LFQ adjusted for the transportation cost between the United States and the Far East. Effective with the week ending July 18, 2019, the <u>transportation adjustment</u> to the LFQ for calculating the LFQ as a percent of the ELS loan rate is <u>17.25 cents per pound</u>. This is changed from the former adjustment of 17.12 cents per pound. The <u>2019 crop loan rate of \$0.9575 became effective August 2, 2019, and is used in these calculations beginning with the week ending August 8, 2019</u>.
