Washington, Tuesday, January 21, 2025 - The U. S. Department of Agriculture's Commodity Credit Corporation today announced the repayment rate and loan deficiency payment rate for wool and mohair. The effective repayment rate is the lower of either the 30-day average or weekly rate.

Loan rates for ungraded wool and mohair remain the same in the 2025 crop year as they were in the 2024 crop year. Producers can continue to utilize the program for the 2024 crop until January 31, 2025.
